From Redlining to Building a Legacy: One Family's Journey

Ralph and Jenny Lyles celebrated a 50th anniversary recently. Not the usual, matrimonial kind, but fifty years of living in the same house in the Harwood neighborhood of Baltimore that they purchased in 1974 with help from the St. Ambrose Housing Aid Center.

When the Lyles bought their house in the early 1970s, St. Ambrose helped cover the down payment on the \$11,500 purchase price. Then, in 2023, St. Ambrose stepped in again to help with needed repairs to the roof and

bathroom so the Lyles could continue to enjoy the house and the neighborhood they've called home for over fifty years. It's all part of the St. Ambrose Legacy Initiative that supports older members of the Baltimore community and helps them age safely in place with

The program isn't limited to needed home repairs but includes resources such as estate planning to support the inter-generational transfer of property to stimulate wealth-building among less well-off communities.

In 1974 when they purchased the house, the Lyles had already been living in it as renters for six years. They had three children, a fourth was soon to come, and they were concerned about making the

transition to homeownership. That's when they learned about St. Ambrose, the organization founded by Vincent (Vinnie) Quayle, a Jesuit seminarian, who was determined to protect neighborhood stability at a time when rental properties were being bought up by outside landlords. The Fair Housing Act of 1968 had only recently been enacted and cities like Baltimore had a long way to go to prevent the "block busting" strategies of real estate agents to manipulate housing prices, and "redlining" by banks and lending institutions to maintain segregated neighborhoods.

Over the years, St. Ambrose has broadened its efforts from helping renters purchase their homes to offering building renovation and weatherization upgrades as well as converting unused Catholic school buildings into affordable apartments. In 2019, St. Ambrose launched the Legacy Initiative to ensure that homeowners like the Lyles would be able to stay in their homes as they aged and then to transfer their properties to the next generation.

As long-term residents, the Lyles have served their Harwood community in countless ways, as president of the neighborhood association and coordinators for the Baltimore Summer Corps to organizing block parties and volunteering with St. Ambrose itself. During hot summer days the block would occasionally be closed off and the fire hydrants opened so the children could cool off.

When reminded of how active they were back then in building a sense of community in their neighborhood Ralph Lyles laughed and said, "we were young."

Today, the Lyles look back with pride in having raised a family in a community where neighbors looked out for each other. Mrs. Lyles, who has low vision, feels secure in a home she's known for fifty years. She remembers

providing daycare services for many of the children who grew up in the neighborhood. Mr. Lyles appreciates that two other houses on their block also received help from St. Ambrose.

As for that other, more traditional anniversary, Jenny and Ralph Lyles celebrated sixty-two years of marriage in March 2024 with their children, four grandkids, and nine great-grandchildren.

Words from a Long-Time St. Ambrose Supporter

Having first heard of St. Ambrose ten years ago, I was impressed with their integrated approach to provide housing stability in the Baltimore area.

I've long believed that education and housing are the two most important components for addressing income and racial inequalities in our country. Having a stable place to live, whether renting or owning, provides the foundation for families to focus on other areas of their lives - education, health, employment - that contributes both to their wellbeing and that of their community.

From its inception in the late 1960s to combat redlining, blockbusting, and other forms of housing discrimination,



St. Ambrose has a proven record of finding housing strategies that work. Also, I'm continually impressed with how the St. Ambrose staff reflect the dedication and joy of the St. Ambrose mission.

A Welcome Home and a Second Chance at Life

Baltimore is a city disproportionately marked by the impacts of mass incarceration. Forty percent of the people in Maryland's prisons come from Baltimore City; however, the City only has 9% of Maryland's population. Baltimore neighborhoods with high rates of incarceration are more likely to have high unemployment rates, high poverty, higher numbers of vacant homes, decreased life expectancy, and higher rates of children with elevated bloodlead levels, compared to other neighborhoods. In communities with high incarceration rates, larger numbers of children grow up with an incarcerated parent, and its corresponding scarcity and trauma.

Communities and people need resources and support to thrive. Investments made to reduce incarceration and poverty improve livability outcomes for individuals, families, and entire communities. But in Baltimore there is a huge gap in the availability of affordable housing accessible to those released from incarceration. From this need, St. Ambrose's 180 Homeshare program was created.

Built on a Homesharing platform created by St. Ambrose Housing Aid Center over 35 years ago, 180 Homeshare provides six-months of free, temporary housing to people who have been incarcerated for at least five years and have just left prison, also called Returning Citizens. Additionally, the program offers case management and connection to supportive services such as physical and mental health services and workforce development to provide holistic support.

Returning Citizens need housing right away in order to get a job, build a safety net, and reestablish positive social relationships in the community. 180 Homeshare provides Returning Citizens with the resources needed to rebuild their lives: housing, a cell phone, bus pass, clothing allowance, gift cards for groceries, and connection to job training and health services. Housing is provided by a host who offers a spare bedroom in their home, shares kitchen and living space and is paid a monthly stipend. As the program approaches its second year in action, we are heartened to share two of the stories of Returning Citizens in the program.

When Troy, 62, was released from prison after 38 years, he returned to a world vastly different from the one he knew in his early twenties. He expected that rebuilding his life would be rife with challenges and finding housing was one. After Troy's initial housing arrangement abruptly ended, he had no place to live. By chance he ran into Thomas Anderson, a 180 Homeshare advisor with lived experience, who took Troy under his wing.

Thomas helped Troy apply for the program and soon Troy moved in with a 180 Homeshare host. They got along "beautifully," but Troy recalls challenges. Having the freedom to come and go was a big adjustment, because every move in prison was controlled by correctional officers. Never having lived on his own, adjusting to a living situation with limited rules was foreign to Troy, and he did not want to disappoint his host by breaking them. Over the next six months Thomas met monthly with Troy to ensure that his transition would be successful. Upon graduation from the 180 Homeshare program Troy found a job in

building maintenance, rented his own apartment and remains in touch with Thomas.

Felix, 33, was a University of Baltimore (UB) student while incarcerated at the Jessup Correctional Institution. Toward the end of his sentence, UB's reentry coordinator told him about 180 Homeshare. Felix met his host over Zoom and they formed an "instant connection" over food. 180 Homeshare's case manager, Siri Morris, met Felix at the prison gate and took him to his new home. He "didn't have two pennies to rub together", wasn't looking for a "handout," and never expected to feel such a warm welcome. It was so unexpected that Felix cried the first night he was home. Like Troy, having the freedom to come and go was challenging, as was sharing a kitchen and bathroom, but his host was so welcoming and warm. Felix now happily rents a house in Federal Hill and works in Annapolis for a marine construction company.
